Before completing and submitting your application to our office, please read all materials and information included. If you have any questions, please call our office at (216) 664-2264 BEFORE YOU APPLY.

A Junk Dealer License is required when dealing, purchasing or selling junk. Scrap metal processors, motor vehicle salvage dealers, salvage motor vehicle auction or salvage motor vehicle pool licensed pursuant to Ohio Revised Chapter 4738 are exempt. However, for each vehicle used in conjunction with this business function, an additional license is required for each vehicle. A separate Junk Cart permit application should be completed and submitted for each vehicle.

A scrap metal processor license is required when processing iron, steel or nonferrous scrap and whose principal product is scrap iron, steel or nonferrous scrap for selling and for re-melting purposes.

Both are annual licenses that expire on August 31^{st} .

You may apply for this license either in-person, online or by mail:

In Person:

- 1. Gather all supporting documentation that must be submitted along with the application (see *What to bring or submit to the Division of Assessments & Licenses Section* below).
- 2. Complete the application in its entirety and sign (print legibly using blue or black ink).
- 3. Visit our office located at the address in the top right-hand corner between the hours of 8:00 a.m. and 4:00 p.m., Monday through Friday.
- 4. Bring the correct fee as listed below. Acceptable forms of payment are money orders, checks, debit/credit cards and cash.

Online:

- 1. Gather all supporting documentation that must be submitted along with the application (see *What to bring or submit to the Division of Assessments & Licenses Section* below).
- 2. Go to https://ca.permitcleveland.org/public/Default.aspx, and follow the instructions on the enclosed attachment.
- 3. Be prepared to submit the license fee listed below plus applicable convenience fees. Acceptable forms of payment are electronic check and debit/credit cards.

By Mail:

- 1. Gather all supporting documentation that must be submitted along with the application (see *What to bring or submit to the Division of Assessments & Licenses Section* below).
- 2. Make copies of all documentation.
- 3. Complete the enclosed application in its entirety and sign (print legibly using blue or black ink)
- 4. Mail the completed application, supporting documentation and applicable fee as listed below to the Division of Assessments and Licenses at the address listed above in the top right-hand corner. Acceptable forms of payment for mailed applications are Money Orders and Checks (DO NOT SEND CASH OR CREDIT CARD INFORMATION IN THE MAIL).

What to bring or submit to the Division of Assessments and Licenses:

- Completed and signed application.
- 2. Copy of current motor vehicle salvage license (if applicable).
- 3. Copies of the Junk Cart license for each vehicle (if applicable).
- 4. Copy of the location's Certificate of Occupancy permit.
 - If you do not have the permit for this location, contact the Department of Building and Housing, Code Enforcement at (216) 664-2910.
- 5. Fee of \$220.00 is due upon application submission for each location. Fees are payable by cash, check or credit card. This fee is non-refundable. Make checks payable to the City of Cleveland.
