Cleveland Division of Recreation Offers Free Summer Meals to Kids

Healthy Meals for all Cleveland Youth Ages 5-18

CLEVELAND – Today the City of Cleveland Division of Recreation announced the beginning of the 2016 Summer Food Service Program for children in the City of Cleveland. The Summer Food Service Program that began this week at all City of Cleveland recreation centers and various partner locations throughout the City is listed below. There is no charge to families or their children to participate in this program.

Meals will be made available Monday - Friday to all children 18 years of age and under; or to persons over 18 who are determined by the state or local public educational agency to be mentally or physically disabled. The meals will be provided without regard to race, color, national origin, gender, age, or disability, and there will be no discrimination in the course of the meal service.

“During the school year, many of our families rely on school meals to meet the nutritional needs of their children,” said Mayor Frank G. Jackson. “This Summer Food Service program assures that our families will not face a void when schools close for summer recess.”
